September 18 to 24, 2016 – The following items were (voluntarily) recalled in Canada and the United States:

### Canada

1. [\*\*Allergens: undeclared mustard and sesame\*\*](#) in Paldo brand Bibim Men Oriental Style Noodle Korean Spicy Taste. Distributed in Alberta, British Columbia, Manitoba, Saskatchewan, and possibly nationwide.
2. [\*\*Allergens: undeclared milk\*\*](#) in Chick Boy brand Pop-Nik snack products. Distributed in Alberta, British Columbia, Manitoba, Ontario, and possibly nationwide.

### United States of America

4. [\*\*Allergens: undeclared shellfish and soy\*\*](#) in Mei Shun Noodle 12 ounce packages of 6?FIVE branded Rice Noodles. Distributed in Chicago, IL.
5. [\*\*Microbiological: \*Listeria monocytogenes\*\*\*](#) in Apple Tree Goat Dairy Feta cheese aged 60 days Lot #836, Gouda Cheese aged 60 days Lot #426, Pasteurized Chevre Lot #816, in 8 oz. or 5 lb, and French Herb Chevre Lot #736 in 8 oz. or 5 lb. Distributed in DC, DE, MD, NJ, and VA.
6. [\*\*Microbiological: \*Listeria monocytogenes\*\*\*](#) in Blue Bell Ice Cream products containing chocolate chip cookie dough (Blue Bell Chocolate Chip Cookie Dough ½ gallon and pints and Blue Bell Cookie Two Step ½ gallon). Distributed in AL, GA, KY, LA, MS, NC, SC, TN, and VA.
7. [\*\*Microbiological: \*Salmonella\*\*\*](#) in Bikaji Chowpati Bhelpuri, Net wt: 300g 10.58 oz Batch no. 2016 F97. Distributed in N, NY, and PA.

8. **Allergens: undeclared shellfish** in Sager Creek Foods Field Peas with Snaps and Green Bean products. Distributed in AL, AR, CO, IL, MD, MO, MS, FL, GA, KS, KY, LA, OK, PA, NC, SC, TN, TX, UT, VA, WI, and WV.

9. **Allergens: undeclared pecans, walnuts, milk and soy** in Good Sense® Cranberries 'N More 6 oz (170g). Distributed in nationwide.
